# DN AGRAR PUBLISHED THE CONVENING NOTICE FOR THE OGMS ON APRIL 28TH

On April 28th will take place the ANNUAL ORDINARY GENERAL MEETING OF SHAREHOLDERS.

The main points on the agenda are:

Approval of the individual and consolidated financial statements of the Company for the financial year 2024.

Approval of the Company's revenue and expense budget for the financial year 2025.

Approval of the distribution of the net profit related to the financial year 2024 in the amount of 5,305,93175 lei, respectively, the allocation of 5% for the constitution of the legal reserve, and the rest remaining unallocated.

Approval of the discharge of the members of the Board of Directors for the activity related to the financial year 2024.

Approval of the compensation package for the members of the Board of Directors, including those with specific roles, for the financial year 2025.

Approval of the renewal of the mandate for the current members of the Board of Directors for a duration of 4 years from the date of its expiration, respectively until 30.06.2029.

# 2025 PROPOSED BUDGET OF REVENUES AND EXPENSES

We present the proposed Budget of Revenues and Expenses for the fiscal year 2025, at a consolidated level, which is to be submitted for approval to the Annual Ordinary General Meeting of Shareholders on April 28th, 2025.

√ The financial projections prepared for 2025 were made taking into
consideration an increase of 10% in milk production at DN AGRAR

Group level compared with 2024, which we estimate will reach a volume of approximately 70 million liters.

 $\mathscr{D}$  Regarding the milk price, we estimate for 2025 the same average price as in 2024.

✓In the budgeted turnover, we have also included revenues from the sale of 3.500 tones of compost that we will produce in the compost factory that was inaugurated in 2024, within DN AGRAR Apold farm. This estimate is based on the current compost market price for Big Bags, with sales scheduled in Q3 and Q4.

### DN AGRAR PUBLISHED THE EGMS DECISIONS FROM MARCH 25TH, 2025

DN AGRAR shareholders approved the items on the agenda of the Extraordinary General Meeting of Shareholders on March 25th. The main decisions adopted were:

Approval to contract an investments credit from ING BANK of EUR 1,665,000 for the implementation of the project "Establishment of a capacity to produce energy from renewable sources", by DN AGRAR Apold, DN AGRAR Service și Lacto Agrar.

Approval to be contracted a credit amounting EUR 1,700,000, for investments into a new compost factory by Lacto Agrar from ING BANK.

It was approved the guarantee by DN AGRAR GROUP S.A., as a shareholder, for DN AGRAR STRAJA regarding the credit line totaling EUR 1,300,000, from by Exim Banca Românească S.A.

DN AGRAR was founded in 2008 by Jan Gijsbertus de Boer and has been listed on the Bucharest Stock Exchange, on the AeRO market, since February 2022. The shares were included in the BETAERO index of the most traded companies in the MULTILATERAL TRADING SYSTEM - SMT, starting September 19th, 2022, and were included in the MSCI Frontier Small Cap and MSCI Romania Small Cap indices on March 1st, 2024.



The company's main areas of activity are animal husbandry, vegetable agriculture production, agricultural services, logistics, transport, tourism and business and management consulting services.
