



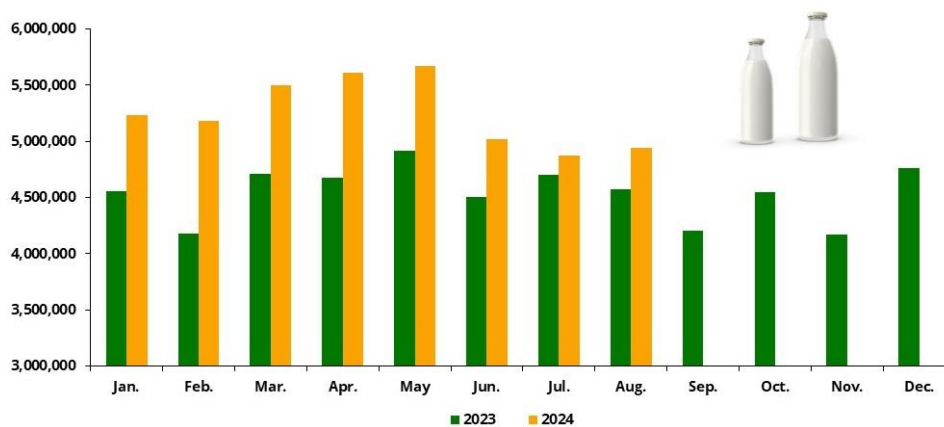
14% INCREASE IN THE QUANTITY OF MILK DELIVERED IN THE FIRST 8 MONTHS OF 2024
